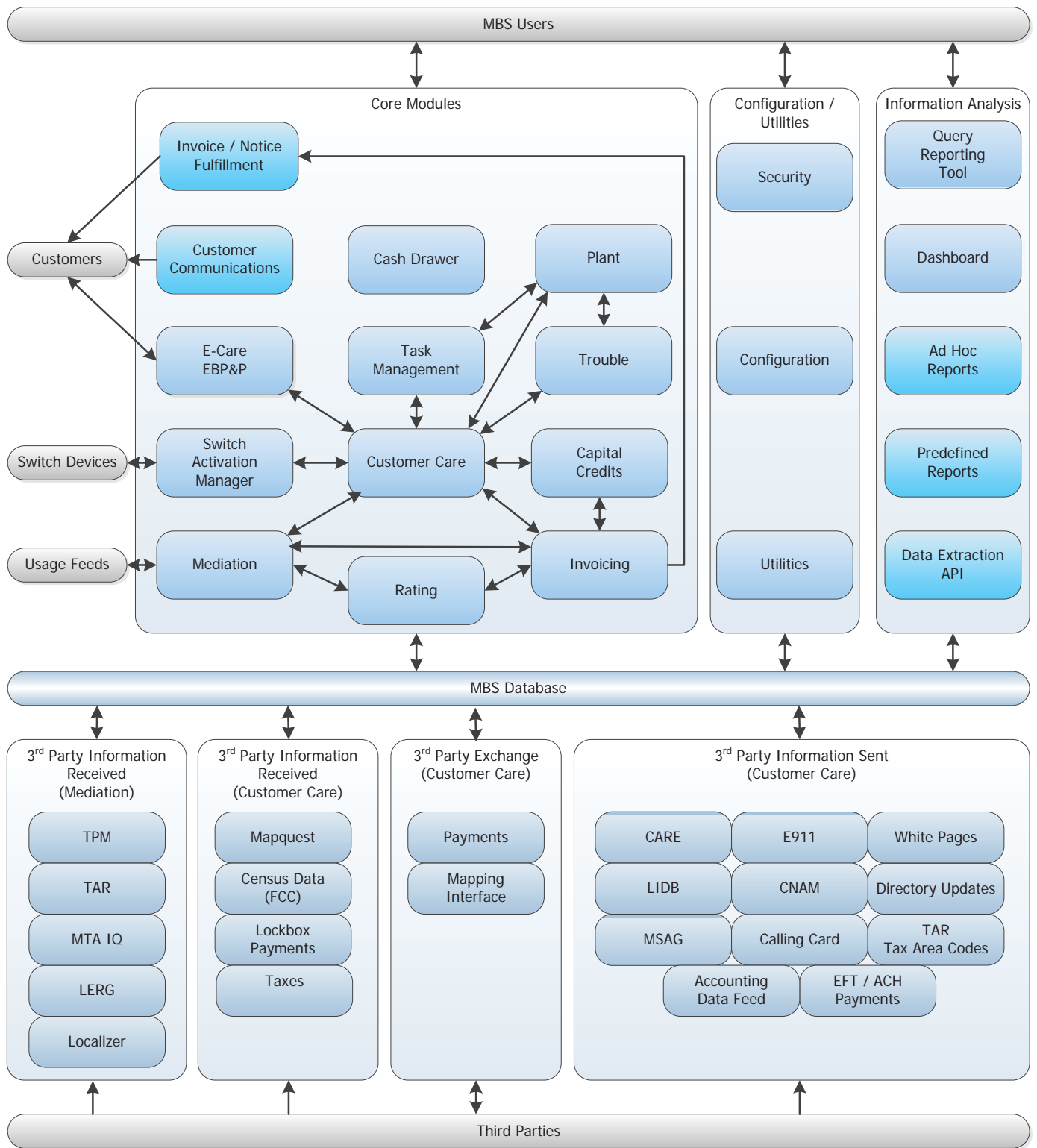


Fig. 1 MBS Functional Overview
